Amfil Technologies, Inc. (OTC PINK: AMFE) was founded in 1986 as Technical Ventures, Inc. A.C.T.S. Inc. was founded in 1998. A.C.T.S. Inc. initially provided consulting and engineering services primarily to the food and beverage manufacturing industry. Growing competition in the food service industry and the changes in the global economy have encouraged management to pursue a new acquisition business model approach. On March 31, 2016, the Company announced its purchase of Snakes and Lagers, an exciting restaurant chain with board games. We believe this acquisition has a Starbucks potential.

The Company intends to raise capital for operating capital and for the purpose of seeking business acquisition possibilities throughout Canada and North America. In May 2014, the Company expanded its existing portfolio by entering into a Joint Venture Agreement to acquire a 50% shared ownership with Antibacterial Cleaning Treatment Services Inc. (A.C.T.S. Inc.) of the mPact - GROzone Antimicrobial Systems.

The Company also acquired the exclusive right of representation to perform with A.C.T.S. Inc. as a Systems and Service Provider to the Medical Marijuana Industry and legal marijuana grow/process establishments or organizations in Canada, North America and globally. The exclusive right of representation is also amenable to the use of the Systems and Service of mPact - GROzone Antimicrobial Systems using A.C.T.S. Inc.'s trade-marked and proprietary products and systems.

Amfil Technologies, Inc.'s first step in building a growth oriented business model resulted in a net positive income generating business by acquiring Interloc - Kings Inc. Interloc - Kings Inc. provides landscape construction and snow removal services in Canada. It is based in the Greater Toronto Area. Interloc - Kings Inc. has increased its customer base by more than +400% percent in the past four years and is now one of the largest residential service companies in the region. The Company has a strong network of strategic relationships with suppliers, distributors and competitors in the industry. This acquisition enabled Amfil to enter a new market with the capacity to expand its product lines and systems and provide a stable and sustainable corporate revenue stream.
