MOST OF THESE SPEAKERS, MEDIA AND HYPE BY SO CALLED EXPERTS HAVE NEVER BOTHERED TO VISIT NORTHERN CALIFORNIA UP HIGHWAY 101.

I HAVE DRIVEN UP HIGHWAY 101 A NUMBER OF TIMES OVER THE YEARS, INTERVIEWING THE KEY LEGAL PEOPLE THERE AND OTHERS IN MENDOCINO COUNTRY. SOME HAVE COME TO MY OFFICES HERE IN SAN RAFAEL, CALIFORNIA TO DISCUSS ISSUES AND REALITY.
